# SECTION I: INSTRUCTIONS TO BIDDERS

## 1. Rights of Public Entity

The Keetmanshoop Municipality reserves the right:

- (a) to split the contract as per the lowest evaluated cost per item, or
- (b) to accept or reject any quotation; and
- (c) to cancel the quotation process and reject all quotations at any time prior to contract award.

## 2. Preparation of Quotations

You are requested to quote for the items mentioned in Section III by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for *Bid Security/Bid Securing Declaration*;
- (b) the List of Goods and Price Schedule Section III;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachments deemed appropriate.

You are advised to carefully read the complete Request for Sealed Quotations document, including the Special Conditions of Contract in Section VII, before preparing your quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

## 3. Validity of Quotations

The Quotation validity period shall be **2 years** from the date of submission deadline.

## 4. Eligibility Criteria

To be eligible to participate in this Quotation exercise, you should:

- (a) have a valid certified company Registration Certificate;
- (b) have an original valid good Standing Tax Certificate;
- (c) have an original valid good Standing Social Security Certificate;
- (d) have a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
- (e) have a certificate indicating SME Status;
- (f) Submit signed Bid-securing Declaration.
- (g) Quotation Letter submitted, clearly indicating the bid validity period
- (h) Completed and signed "Section V: List of Goods and Price Schedule"
- (i) completed and signed Section VI: Specifications And Compliance Sheet"
- (j) Fully completed and signed Technical Schedules
- (k) Delivery of goods shall be **12 or less weeks** after issue of Purchase Order.

- (l) The bidder must submit proof of having a warehouse or operating premises for electrical items or agreement with a local retailer.
- (m) Submit a reference letter for Electrical Equipment offered from any Namibian utility or electrical distributor.

#### **5. Bid Security/Bid Securing Declaration**

Bidders are required to submit a Bid Security/subscribe to a Bid Securing Declaration for this procurement process. The Bidder shall furnish as part of its quotation, a Bid Security as per the format contained in Appendix to Quotation Letter of this document for 2% of the quoted price valid up to 30 days beyond the quotation validity period.

#### **6. Delivery**

Delivery shall be eight (8) to twelve (12) weeks after acceptance/issue of Purchase Order. Deviation in delivery period shall not be accepted

The following test and inspections will be conducted on the goods at delivery:

- Inspection of any visible damage and oil leakages.
- Verification of compliance to specifications
- Verification that all Routine and Type test certificates are in place

#### **7. Sealing and Marking of Quotations**

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name and contact information at the back of the envelope.

#### **8. Submission of Quotations**

Quotations should be deposited in the Quotation/Bid Box located at Keetmanshoop Municipality Head Office, 37 Hampie Plichta Avenue, not later than 1 February 2021, 11H00. Quotations by post or hand delivered should reach Keetmanshoop Municipality Head Office, 37 Hampie Plichta Avenue by the same date and time at latest. Late quotations will be rejected.

**Quotations received by e-mail will not be considered.**

#### **9. Opening of Quotations**

Quotations will be opened internally by the Public Entity immediately after the closing time referred to in instruction 8 above. A record of the Quotation Opening stating the name of the bidders, the amount quoted, the presence or absence of a Bid Security/Bid Securing Declaration, will be posted on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

#### **10. Evaluation of Quotations**

The Public Entity shall have the right to request for clarifications in writing during evaluation. The Keetmanshoop Municipality's evaluation of a bid will take into account, in addition to the Bid Price quoted the mandatory documents requested in the checklist below (part 1 ), then the Bid shall be treated as **non-responsive**.

## **SECTION IV: SPECIFICATIONS AND PERFORMANCE REQUIREMENTS**

1. For the **Ring Main Units (RMU's)** refer to the relevant sections as outlined in the Specification and performance requirements of **Annexure A (KEBU\_SPEC\_007)** (SPECIFICATION FOR MEDIUM-VOLTAGE SWITCHGEAR AND ANCILARY EQUIPMENT) and **Annexure B (KEBU\_SPEC\_007)** (Technical Compliance Schedules A and B)
  
2. For the **Battery Tripping Units (BTU)** Specification and performance requirements see below:
  - 2.1. A battery tripping unit, suitable for connection to a 230 V, 50 Hz, single-phase a.c. supply shall be provided with each switchboard.
  
  - 2.2. The charger shall be metal-clad and shall be suitable for charging a Ni-Cad battery with voltage and capacity as specified in the detail specification.
  
  - 2.3. The charger shall be such that the change-over from trickle to boost charge is automatic.
  
  - 2.4. The tripping unit shall be supplied complete with fuses on the a.c. supply side and on the outgoing d.c. side of the charger, an ammeter to indicate the charging rate, a voltmeter with spring-loaded push buttons to indicate battery voltage and a circuit to test the state of battery charge.
  
3. **Kiosk** (for free-standing outdoor ring main units)
  - 3.1. If a kiosk is required, it shall be stated in schedule A.
  
  - 3.2. The kiosk shall be constructed from materials in accordance with 8.11. All kiosks shall be finished in Avocado (C12) in accordance with SANS 1091.
  
  - 3.3. Where a kiosk is required, the ring main unit shall be supplied with the kiosk, i.e. the ring main unit shall be fitted by the manufacturer into the kiosk, and the assembly shall be supplied as one unit.

- 3.4. The kiosk and RMU shall be tested as an assembly in accordance with the requirements of clause 5 of SANS 1874.
- 3.5. A three-point locking mechanism on the access door shall have an additional, captive, 10 mm stainless steel Allen cap screw. The cap screw shall be recessed, i.e., the head shall be flush with the door surface and the screw shall lock the swivel mechanism of the three-point locking device when the mechanism is in the closed position.
- 3.6. Each door handle shall be capable of being secured by means of a padlock having a shackle diameter of 6 mm.
- 3.7. The kiosk shall have a lock protection facility over the locking device, to prevent tampering with the lock.
- 3.8. Suitable lifting eyes shall be attached to the kiosk (at the top of the kiosk) and RMU. The lifting eyes shall be designed to lift the kiosk with the ring main unit fitted inside. Lifting eyes with a minimum diameter of 30 mm shall be provided.
- 3.9. A steel documentation pocket shall be provided for the safe-keeping of all relevant documentation (i.e. installation, operating and maintenance instructions for the ring main unit and all routine test certification) on the inside of the kiosk door. The means used (e.g. pop rivets) to secure the pocket shall not protrude through the door.
- 3.10. The kiosk doors shall be fitted with a facility to enable them to be held open at an angle of at least 90°, to allow operation under windy conditions. The facility shall be robust to withstand the force of wind and weather under adverse conditions.
